# b. Office of Internal Audit FY24 Work Plan Revisions

Ms. Kalil has the responsibility to periodically review the work plan and make adjustments as necessary. Those adjustments would be in response to any changes in strategies or risk or in response to any changes in resources. Due to Board of Governors regulations, emerging risks, and resource limitations, adjustments need to be made. Those adjustments include moving hours to new projects, incorporating some supplemental audit services, as well as removing some hours due to vacant positions. Specifically, additions include a Post-Tenure Faculty Review as well as Procurement Card (PCard) program reviews, lpenw lpi 'y g'wpksgtuk au'r tqi tco 'as well as four PCard programs administered by our Direct Support Organizations. Deferrals include Decentralized HR Controls, USF Health Research, College of Nursing, and

Degree Certification.
