First Order of Business:

x Administrative Overhead (Discussion)

An overhead expense of 6% is added to project costs. Example, if a project is \$100,000, the Council award will be \$106,000 (\$100,000 for project costs + \$6,000 for administrative overhead.) The reserve for administrative overhead expense is established when the budget for the project is created. It shows as a separate line of the project budget. Administrative overhead is charged as expenses are paid.

x Contingency (Discussion)

Typically, a contingency allowance of 10% is built into project budgets that are difficult to estimate due to complexity factors like the price volatility of supplies and materials or unanticipated additional expenses revealed as the project unfolds. The contingency reduces the need for the Principal Investigator to request additional budget. The SGE Charter also allows for projects to go over budget by 10% without requesting approval from the SGE Council. If the budget for the project appears likely to exceed the 10% threshold, then the Principal Investigator must request a budget amendment from the SGE Council. For example, the Roadway LED Light Project is a recent example of a project requiring additional budget that the Council approved.
